

**Sub:- Local officiating promotion and posting in SDE of TES Gr.B .**

The Officers as per the enclosed Annexure are hereby promoted on a purely temporary and local officiating basis to the cadre of SDE of TES Gr-B in the SSAs as shown against their names with effect from 31/01/2011 (F/N) for 180 days to the period ending 29/07/2011 (A/N) or till further orders from this office.

**Those who were working as SDE(O) in the earlier spell will be considered for Officiating promotion w.e.f 31/01/2011 .** For remaining Officers the date of promotion will be from the actual date of joining.

On completion of the officiating period, the officers will stand reverted to their substantive cadre on 29/07/2011 (A/N) irrespective of whether they have joined with immediate effect or thereafter or unless reverted earlier due to any other reasons.

This officiating promotion will not entitle the officers for any claim for regularization or counting the officiating period for continuity or any other benefit.

It may kindly be ensured before relieving the officers that no disciplinary/vigilance case is pending against them and no punishment is current.

All the officers may be relieved immediately with instructions to join their duties as SDE on officiating basis and they are directed to join their new assignment without fail.

Refusal, if any from the promoted official received/intimated should be communicated to this office within 15 (fifteen) days from the date of issue of this order by name to the undersigned without fail.

The Heads of SSA are further directed that the pending request of the officer(s) for modification of the promotion orders cannot be taken as a ground for holding up the implementation of the orders in respect of the concerned officer(s). Accordingly officers are to be relieved unless otherwise refusal has been submitted by the officer concerned.

In case an officer is refusing the promotion he will not be considered for further officiating period for a period of one year. If the officer is already transferred to other SSA as JTO and not yet relieved and covered under this order for SDE officiating promotion, he may be relieved to the posted SSA as per the earlier transfer order to get his further promotion as SDE officiating after joining in posted unit. Such cases if any may be intimated to this office separately.

The arrangements made under this order will neither bestow on the officer any right to claim for regular appointment in the grade of SDE nor will the services rendered by them count for the purpose of seniority in the grade or for promotion to the next grade or any other benefit.

**The pay of the Officers may be fixed as per 2<sup>nd</sup> PRC recommendations.**

This order is issued with the approval of the competent authority.


